Trap Round Up & BIG 50 ATA Mini-shoots

The **Winter Trap League** is in full swing with 14 avid trap shooters participating. The League started January 10 and runs until March 14 on Sunday mornings starting at 9am. Rain, shine, or snow these folks come out and shoot up the clays!

There are **BIG 50** weekly shoots that run concurrent with the league on Sundays, but are open to non-league shooters as well. These are 50-round registered trap events as compared to the standard 100 or 200 target events. It's an easy way to get some registered targets in toward your minimums for State and larger shoots to avoid penalty class or yardage. Daily ATA and MTA fees are reduced as well. We have several folks who shoot these with and without the Winter League. If you shoot league, you can cross register your league scores just by paying the daily fees, so you're still only shooting the 50 targets. It's a win-win! The BIG 50 is also a great way for youth shooters to get targets in.

Open trap and skeet are also going strong on Sunday mornings starting at 9am. You can still come out for practice shooting some clays and not be part of the league or BIG 50 shoots. 5-Stand is put away for the winter though.
