Self-Defense "Kubotan" Class:

The Kubotan is a form of the Japanese Yawara stick, a martial art weapon designed as a lever/force multiplier for compliance, holds, and take downs. The modern version is a plastic or metal 6" "stick", carried as a stand-alone device or on a key chain. Class is "hands on". Students will be applying holds and working with other students and instructors for the duration. Included with tuition, each student will receive their own Kubotan to take home.
